### Tank Mixing Instructions:

Mix at a ratio of 1 part to 30 parts of water for sprayer tank mixing. Once mixed, it will remain in suspension. May be applied by spraying, fertigation, pivot irrigation, tape irrigation, overhead irrigation, hose end applicator, or by hand drenching. Light irrigate after spraying. It may be necessary to remove inlet pump and nozzle filters from some models of sprayers.
